Income-related expenses for employmentReceipts and evidence for:

- Expenses for labour court lawsuits (lawyer, court)

Receipts and evidence for:

- Practice fee, medication, dentist, glasses

- Medical aids (bed, stair lift,...)
- Costs for divorce/funeral
- Care level certification
- Institutional care/household care
- Alimony to relatives
- Alimony to children (e.g. over 25 years old, in education)

Alimony to refugees from Syria (declaration of commitment)

Further documents for saving tax

- Services of craftsmen (chimney sweeper, drain cleaner, electrician, window fitter, roofer, carpenter, plumber, tiler, painter e.g.)
- Services related to household (gardening, household care, au pair, nursing service e.g.)
- Utilities statement from property management or the landlord
- Expenditures may only be deducted on presentation of an account statement (bank transfer obligatory). Just wages are deductible (possibly plus VAT), material expenses are not deductible.
- · Application for housing subsidy.
- Riester: Application for bonus for private retirement plans
